NOTICE OF INTENT TO AWARD CONTRACT

On October 28, 2020, Deschutes County 911 RFP review committee considered bids for the above-referenced project. The review committee determined that the successful bidder for the project was CDX Wireless Inc., Lafayette, Colorado, with a base bid of SIXTY THOUSAND NINE HUNDRED TWENTY DOLLARS (\$60,920).

This Notice of Intent to Award Contract is issued pursuant to Oregon Administrative Rule (OAR) 137-047-0610. A copy of this Notice is being provided to each firm or person that submitted a bid for the project. Any firm or person who believes that they are adversely affected or aggrieved may submit to David Doyle, Deschutes County Legal Counsel, a written protest of Deschutes County 911's intent to award within seven (7) days after the issuance of this Notice of Intent to Award Contract. The seven (7) day protest period will expire at 5:00 P.M. on Thursday, November 12, 2020. Written protests may be submitted to the following address:

Any protest must be in writing and specify any grounds upon which the protest is based. If a protest is filed, a hearing will be held before the Board of County Commissioners of Deschutes County, Oregon, acting as the Contract Review Board, in the Deschutes Services Building, 1300 NW Wall Street, Bend, Oregon 97703.

If no protest is filed within the protest period, this Notice of Intent to Award Contract becomes an Award of Contract without further action by DC 911 or the Board of County Commissioners unless the County Administrator, for good cause, rescinds this Notice before

the expiration of the protest period. [Be advised that if no protest is received within the stated time period that DC 911 is authorized to process the contract administratively.] The successful bidder on a Deschutes County 911 project is required to execute the Contract provided by DC 911 when the bids are finally determined. In addition to the execution of Contract, the contractor will be required, as applicable, to provide a performance bond, payment bond, and certificate of insurance.
