**Date of Notice Issued:** January 9, 2017

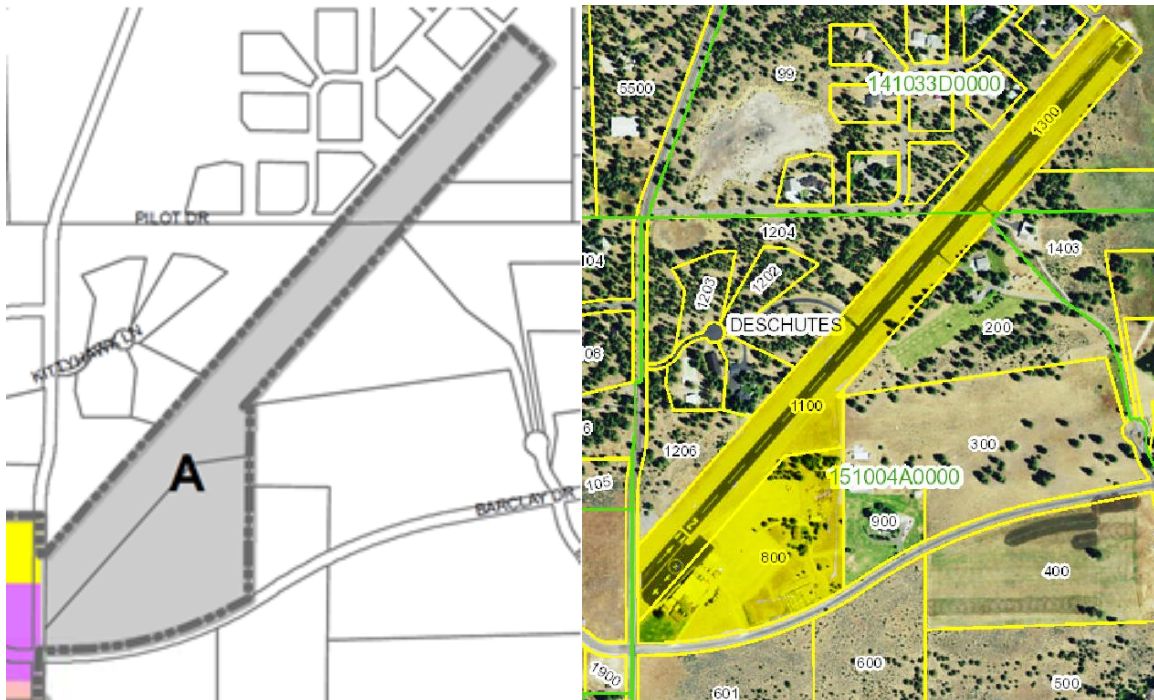

Exhibit 2 has also been referred to as **Appendix “M”** being identified in the Department’s Airport Land Use Compatibility Guidebook which lists Privately Owned Public Use Airports that: Provide Links in Essential Safety, or Emergency Services, or Are of Economic Importance (Adopted by the Aviation Board in January 2003).

### ***ODA's Review Process:***

The review process is identified OAR 738-090-0040(2)(a-g). Once the public review process is complete the Department shall evaluate the proposal based upon criteria in ORS 836.610(1)(b) and comments received from the airport sponsor, local governments and testimony taken at a public hearing. The Department shall make a recommendation to the Board whether the proposed action should be approved or denied.
